





In those days there was no Schengen visa and one had to apply separately for each individual country. After my Europe tour, I decided to stay back in London and pursue further studies. I enrolled for a double degree in Company Secretary & Administration (ICSA) at the London School of Business. In September 1992, I met an immigration attorney from a prestigious law firm in Montreal, Canada, in London. This law firm specialized in Canadian immigration matters and was looking to expand their practice in India. I proposed to

him that we could work together and start immigration practice in India," Prashant recalls his journey of establishing the Law Firm of Prashant Ajmera & Associates.
