There are very detail requirement for each province and meeting minimum requirement is not an automatic approval of application.

General requirement and process for all types of PNP business immigration:

1. Applicant must have CD\$ 500,000+ and more in net assets in your and spouse name. (Parents assets by inherence or gift may be counted provided it is transferred in your / spouse name 6 months before the application. Affidavit is not acceptable) PEI Does not allow inheritance unless by will or GIFT.
2. 2-3 years of experience of running and managing a business or senior executive in a company
3. Preferably 4 to 5 band in IELTS
4. A business exploratory trip to Canada
5. Decide and make a business plan for starting a new business or purchasing an existing business or in partnership with some one
6. Apply to PNP immigration department by online application – Expression of Interest
7. If Business plan is approved, an application needs to be made with documents.
8. On approval of application, a business work permit needs to be applied.
9. With business work permit travel to Canada and start your business by investing the necessary amount within range to CD\$ 100,000 to 250,000 in most cases.
10. On managing and running a business for two year, final 3rd approval is received to apply for PR of Canada from within Canada.
11. In two years applicant needs to create 1-2 jobs as per requirement.
12. After two years of PR in Canada, you can apply for Citizenship of Canada.
13. Once you have citizenship of Canada, you can apply for E1-E2 Business visa of USA.
14. You can sponsor your parents and brothers and sisters less than 22 years of age.
